STATEMENT ON MODERN SLAVERY

Segetex-eif is a privately-owned French company based in France, with offices in the UK, Ukraine and China. The company manufacturers single-use solutions from non-woven fabrics, supplying PPE, RPE and medical products in the industrial, commercial and healthcare markets.

Our workforce consists of full time and part time employees working from our Head Office in Paris, and other factory and office locations. Our supply chain providers are predominantly based in Ukraine, France and China.

OUR COMMITMENT

Since the passing of the UK Modern Slavery Act in 2015, we at Segetex-eif are committed to ensuring that there is no human trafficking, forced labour or inhumane treatment of workers within our supply chain. We work very closely with all our supply chain providers to ensure that we only ever trade with ethical partners.

We are committed to acting ethically and with integrity in all our business relationships and to taking reasonable steps to ensure slavery and human trafficking are not taking place in any business or organisation that has any sort of relationship with us.

DUE DILIGENCE PROCESSES FOR SLAVERY AND HUMAN TRAFFICKING

Segetex-eif has a zero-tolerance policy towards slavery and human trafficking. We expect all organisations in our supply chain to comply with our values.

As part of our initiative to identify and mitigate risk, we have an established and fully audited Labour Standards Assurance System (LSAS) in place, which covers all aspects of labour standards, including Modern Slavery. We have processes in place to encourage the reporting of any labour standards concerns or abuses within our supply chain and we ensure the protection of whistle-blowers.

We require all supply chain providers to have suitable anti-slavery and human trafficking policies and processes in place.

TRAINING

The Segetex-eif management team is responsible for LSAS compliance and each department head is responsible for its respective area and have been trained accordingly.

All employees receive an induction into the business where our LSAS policies, procedures and expectations are outlined.

We also have an appointed LSAS Management Representative. This person is responsible for the coordination and management of our LSAS and reports directly to Senior Management.

EFFECTIVENESS IN COMBATTING SLAVERY AND HUMAN TRAFFICKING

Segetex-eif uses the following key performance indicators to measure how effective it has been in ensuring that slavery and human trafficking is not taking place in any part of its business or supply chain:

• We collect relevant data to monitor and measure our LSAS performance against stated objectives and targets.

• We have established a procedure of internal audit that checks conformance with arrangements for labour standards assurance.

• We engage with clients, suppliers and other external interested parties to review and inform on performance monitoring and measurement.

• We regularly review supply chain policies, codes of conduct and our working practices.

• Our LSAS is periodically reviewed by Lloyds Register, an independent, third party assessment body. This statement is made in accordance with section 54(1) of the Modern Slavery Act 2015 and constitutes the Company's slavery and human trafficking statement.

The Slavery and Human Trafficking Statement is hereby approved by the company owners of Segetexeif.
